To whom it may concern,

The VECTOR vehicle you have procured contains embedded items that are subject to US export control regulations. This means that there are restrictions on the export of this vehicle to a foreign (non-US) nation.

The UK MOD has carried out a Commodity Jurisdiction (CJ) self-assessment in relation to this vehicle in order to establish the US export control status of both the vehicle and the items embedded within. This information is detailed within Enclosure 1.

The VECTOR is subject to a de minimis calculation of 2.65% at time of print. However, re-export from the UK for end-use in a country in Country Group E:1, E:2 and D:5 in Supplement 1 to Part 740 of the US Export Administration Regulations:

would require authorization by the US Government.

This assessment has been undertaken with all available data. The assessment included within Enclosure 1 covers the basic VECTOR variant. A full analysis of all VECTOR variants (i.e. the VECTOR platform) could not be conducted at this time.

Items controlled under the US Export Administration Regulations (EAR) are regulated by the US Department of Commerce and further information can be found on their government website. Items controlled under the US International Traffic in Arms Regulations (ITAR) are regulated by the US Department of State Directorate of Defense Trade Controls (DDTC) and further information can be found on their government website. The owner of this vehicle must ensure these regulations are adhered to, and that any restrictions related to the item(s) identified within Enclosure 1 are understood, and complied with. Failure to do so could lead to a violation of the regulations.

Should any controlled materiel listed within Enclosure 1 be removed from the asset, it will need to be treated in accordance with the applicable regulation.
